Loss Damage Waiver Addendum to Rental Contract

The purchase of this LDW is not mandatory and may be declined if customer provides proof of other acceptable coverage.

By signing below, customer agrees to pay a fee equal to 15 percent (%) of the gross rental charge or \$15.00, whichever is greater. In exchange for the receipt of such fee, lessor shall waive claims against the customer for loss or damage to equipment, provided that the equipment is used in strict compliance with all terms of this agreement, including, without limitation, the Terms and Conditions of Rental.

The customer is responsible for paying the \$1,000 deductible for any valid claim.
